Purpose of the MoU:

The purpose of this MoU is to establish a formal collaboration between College shri. Eknathrao sahadu Shete arts, commerce and science college, Deolalicamp Bhagur and late. B.R.D. Arts ,Commece and science Mahila Mahavidyalay, Nashik road. to foster academic and educational exchange, support faculty development, and enhance the overall learning experience for students in areas of mutual interest.

Scope of Collaboration:**1. Academic and Faculty Collaboration:**

- Both institutions agree to collaborate in various academic activities, such as:
 - **Joint Research Initiatives:** Collaboration on research projects and publication opportunities.
 - **Faculty Exchange Programs:** Faculty members from each institution may visit the other college to conduct lectures, workshops, or seminars.
 - **Shared Curriculum Development:** Development of courses or modules to be offered jointly or for cross-institution enrollment.

2. Student Exchange Program:

- **Duration:** Students may be exchanged for a period of [36 months], with the aim to enhance their academic exposure and learning.

- To facilitate academic and administrative coordination for collaborative efforts.
- To contribute to the sharing of academic and research resources with College A.

Terms and Conditions:

1. Duration of the MoU:

- This MoU will be effective from and will remain in force for [36 months], subject to renewal or extension upon mutual agreement.

2. Review and Evaluation:

- Both institutions agree to meet periodically to review the progress of the collaboration and evaluate its success, making necessary amendments to improve the partnership.

3. Confidentiality:

- Both institutions agree to maintain confidentiality regarding proprietary or sensitive information shared during the collaboration, including research findings, student data, and financial matters.

4. Termination:

- Either institution may terminate this MoU by providing [36 months] notice in writing, with clear reasons for termination. In the event of termination, both institutions will ensure the smooth completion of any ongoing activities.


5. Dispute Resolution:

- Any dispute arising from this MoU will be resolved through mutual discussion and negotiation. In the event of failure to resolve the dispute, it will be referred to an arbitrator chosen by both institutions.
